Purpose:

The Florida Vegetation Management Association (FVMA) scholarship is intended to promote education and leadership by awarding one or more \$2,500.00 scholarship to a qualified student majoring in a field of study directly related to “vegetation management”.

Recognition to be awarded:

The scholarship recipient(s) will be selected by a committee of FVMA members, appointed by the FVMA Board of Directors, and will receive the following:

- A certificate commemorating the award
- \$2,500 cash scholarship
- Invitation to attend the Annual FVMA Conference

Eligibility:

- At the time of application, applicant must be a U.S. Citizen.
- Applicant may be seeking a Certificate, Undergraduate or Graduate degree.
- To be considered, the applicant must submit a transcript to confirm their overall GPA for the preceding school year is at least 3.0 (out of 4.0).
- At the time of application, the applicant must already be enrolled in an accredited university or college within the State of Florida and scheduled to start school within **the 2026** calendar year. In the event a recipient withdraws from the university/college or changes to a non-eligible field of study, that student will not be eligible for additional support from the FVMA.
- The student must be majoring in a field of study with a demonstrable concentration or emphasis on vegetation or natural resources management.

- _____ College or university acceptance, letter or proof of bachelor degree (if entering graduate school)
- _____ Most recent High School or College transcript (Un-official is acceptable)
- _____ (1) One single-page, typed essay explaining the applicants’ views on the importance of vegetation management and your future career plans
- _____ (Optional) Letter of recommendation
- _____ Most recent high school or college resume, highlighting your personal and academic achievements. Applicants are encouraged to provide detailed information on extracurricular activities, community service projects and honors received.
